2023 Meigs County Board of Health **ENVIRONMENTAL HEALTH FEES** for **PERMITS, LICENSES, and LATE FEES** are effective as of January 1, 2023 (unless other deadlines apply). All local fees are in addition to any applicable state fee. Late fees and penalties apply as set forth by the Ohio Revised Code or local rules. Local fees are established to defray costs not covered by levy or grant funding. There is a \$25.00 returned check fee.

**ALL FEES MUST BE PAID PRIOR TO PERFORMANCE OR ISSUANCE. FAILURE TO DO SO WILL INCUR A PENALTY FEE. (See below for penalty schedule)**
